Law on Residence for the Purpose of Studying

1. Visa Issue Requirements:

- Acceptance letter from an educational institution (eg. Acceptance for studies, German course or obligatory internship)
 - → Residence permit will be issued for 1-2 years

2. Social Services und Work:

- X Social services (Housing and child benefit, BAföG [Federal Law on Support in Education] (only in special cases!))
- √ Special church / university / DAAD funds
- ✓ Part-time job: 120 days or 240 half days a year
- √ Student part-time jobs

Law on Residence for the Purpose of Studying

3. Family Reunification:

- Proof of livelihood for partner and children
- Proof that the resident in Germany has enough space in their home for the whole family.
- Valid only for the duration of studies of the student.
- Gainful employment for the partner is not limited.
- Only for marriages that have been registered before entry to Germany.

(cf. § 27 Principle of Family Reunification)

Law on Residence for the Purpose of Studying

4. Residence after Completion of Studies:

- can be extended up to 18 months for the purpose of searching for suitable employment opportunities
- right to take up and pursue gainful employment of any kind within this period

What is "suitable employment" ?

- Job should correspond to one's educational qualifications in terms of salary, content and position.
- Example: Student with Degree in Economics Finances finds a position in the finance department of a company. Receives a customary salary. She receives a permanent position after a year of traineeship.

1. Appointment:

- <u>approximately</u> 2 months before the expiry of the residence permit, you would receive a letter with the required documents
- after the documents have been checked by the Immigration Authorities, you would receive an appointment

2. Required Documents:

- Passport
- Filled application form for extension of residence permit
- 1 recent biometric photo
- Recent certificate of matriculation
- Proof of blocked account or certificate of undertaking according to the Law on Residence for the Purpose of Studying (solvency of the applicant has to be proven)
- Proof of current health insurance (for private insurance, see information sheet)
- Proof of your previous academic performance [Leistungsnachweis]
- Fees: up to 100 € (extension fees 96€, fictional certificate 13€)
- If applicable: proof of scholarship

3. Forms for Download:

- Application form for issuance / extension of a residence permit (PDF)
- Information sheet on required protection by health insurance, to be completed by insurance company (PDF)

What is this?

- The Immigration Authorities may require an official statement from the university when you **renew your residence permit**.
- If this is the case, you would receive a letter of **invitation for a consultation** with the International Office, via email.
- The statement will be discussed during a personal and confidential consultation with our study advisors at the International Office.


The aim of the consultation is to discuss the number of courses and exams you have completed and your plans for the rest of your studies.

Please hand in / bring along:

- a proof of your previous academic performance (Transcript of Records)
- a complete list of all the courses you will attend as part of your degree course
 as well as the respective amount of Credit Points
- a proof in case there are specific reasons for a delay in your study progress (e.g. medical certificate, leave of absence (Urlaubssemester), or similar)
- information on the validity of your current residence permit (expiry date)





Application for Leave

Reasons for an Application for Leave:

- long-term illness (proof from doctor required)
- obligatory internship for your studies
- stay abroad for your studies
- maternity leave or care of relatives

NOT a reason for an Application for Leave:

- Preparation for graduation exams
- Late arrival
- Financial need

Change of Subject

Take note:

- Change of subject should be applied for as early as possible!
- Subject can only be changed once within the first 3 semesters without a reason.
- A change of subject after the first 3 semesters may affect your residence permit → Go for counselling!

Change of Subject

Sometimes it may be necessary to change your course of study. If you notice the following, please go for counselling:

- decreased motivation
- poor results and multiple failed exams
- fear of exams and permanent high stress levels
